ALL FEA-R and FCRE members are encouraged to join in this year's bus trip to Richmond to lobby our legislators. With the many wins among our endorsed candidates, our voices have the potential to be heard more loudly and clearly as we stand up for our legislative agenda! The bus will stop at three different places to pick up participants along the way.

Stop #1 is the parking lot at the Fair Oaks Mall, between poles 55 and 58. You can see the Mantech Building sign from poles 55-58, but that building IS NOT on the Fair Oaks Parking Lot property. The bus will leave that area at 6:00 a.m.

Stop #2 is the parking lot of Little River United Church of Christ at 8410 Little River Turnpike, Annandale, across from Northern Virginia Community College. The bus will leave for Richmond from there at 6:30 a.m.

Stop #3 is the Cracker Barrel, just off Rt. 95, at 17115 Dumfries Road, Dumfries, VA. The bus will leave from the Cracker Barrel between 6:50 and 7:00 a.m.

Retirees will meet with legislators during the morning after the briefing. The General Assembly Building will be closed for renovation during the next four years!! The bus will leave the Richmond area by around 3:00 and will return sometime between 5:00 and 6:00 to the stops that were made in the morning.



Substitute Pay Still on the Front Burner

FEA-R has kept this issue alive in talks with Human Resources and School Board members and will keep pushing for re-instatement of higher pay for retired subs as well as others who choose to support the school system in this way.

Having been an FCPS teacher, Superintendent Scott Brabrand knows the difference a competent sub can make in the classroom. In an hour-long meeting with the FEA-R Council in September, he spoke about coming up with ways to better compensate and attract subs. In addition, he recognized the value that retirees bring to the classroom and the toll it takes on teachers and IA's to fill in during their planning time.

Position Statement for the 2018 General Assembly Session

ON BEHALF OF ALL NORTHERN VIRGINIA'S RETIRED EDUCATION EMPLOYEES, THE MEMBERS OF THE FAIR-FAX EDUCATION ASSOCIATION-RETIRED AND THE FAIRFAX COUNTY RETIRED EDUCATORS SUPPORT THE FOLLOWING:

- 1. Fully fund the Virginia Retirement System (VRS) and maintain it as a defined benefit plan without any other option.
 - A. **IMPLEMENT** VRS actuarial recommendations, including continuing to fully fund the Board Certified Contribution Rate to VRS.
 - B. **OPPOSE** all efforts to erode the VRS retirement plan.
- 2. Provide equity for ALL education employees, bringing them to the level of benefits provided to state employees in comparable positions.
 - A. This increase should be appropriated from the state funds and NOT from local revenues.
 - B. Provide health insurance credit to all educational support professionals (ESP).

IN SOLIDARITY WITH OUR ACTIVELY EMPLOYED COLLEAGUES, RETIRED EDUCATORS ALSO CALL ON LAW-MAKERS TO:

- 3. Commit to providing a high quality environment for teaching and learning.
 - A. Attract and retain highly qualified educators.
 - Recognize the importance of professional autonomy for practitioners and provide avenues for their input.
 - Maintain the current continuing contract.
 - Reinstate the three person fact-finding panel.
 - Restore a three year probationary period for new teachers.
 - Significantly improve educator salaries.
 - B. Continue to examine and evaluate the frequency and dependence on high stakes testing.
 - C. Promote a teacher evaluation system that uses multiple measures, reduces reliance on standardized test scores, and reflects a teacher's effectiveness.
 - D. Oppose voucher and tax credit plans for private and home K-12 education.
- 4. Fully fund SOQ mandates, including significant reductions in class size, and revise the funding formula to more accurately reflect the needs of all localities.
- 5. OPPOSE Charter School Amendments and/or any attempts to divert public dollars to non-public schools.
- 6. Support Medicaid expansion to provide necessary health care to children of low income families and to bring additional federal funding to the Virginia General Fund.

VEA-R Honors Barbara Allen

On April 20, 2018, the Virginia Education Association-Retired will honor Barbara Allen with its Distinguished Service Award for her decades of work on behalf of retired educators, children, and public education.

Before retiring from FCPS in 2005, Barbara served as a president of the FEA from 2002-2004 after serving many years as chair of FEA's political action groups. During that time, she and others became interested in forming a local retiree organization associated with the VEA and the NEA, so she formed an ad hoc committee of retirees to begin work on the project.

Once retired, she again turned her attention to her true passion—politics—continuing to lobby the School Board and Supervisors on behalf of education issues. Joining the Board of Directors of the recently founded Fairfax Education Association-Retired, Barbara became that organization's Government Relations Director. When she became active in the Fairfax County Retired Educators (FCRE), she joined its council as well. When asked to head FCRE's government relations group, she agreed on the condition that the lobby efforts of both FCRE and FEA-R be joined—one director, one committee, one set of goals and activities. Both organizations agreed.

Ever since, Barbara has led retiree lobbyists into meetings with county and state lawmakers. Virginia State Senator Richard Saslaw wrote recently that Barbara is "a staunch advocate for public education...she is no stranger to the halls of the General Assembly... {She} is known for her grasp of the issues." State Delegate member Vivian Watts agrees, writing, "I don't think any General Assembly member from Fairfax would be able to recall a time when Barbara was not shepherding a group of colleagues to meet with us... {to} have a meaningful, relevant dialogue..." We are working with NCPERS, NPPC, and NEA bringing information from national pension and association organizations to help our fellow county workers.

Unfortunately, the County Board is as determined to undermine retirement benefits for new hires as the School Board was last year, and the challenge to hold onto equal benefits for 2019 employees will be a challenge.

FEA-R members can help tremendously by calling, e-mailing, or sending letters to your Supervisor and asking friends to contact theirs as well. Ask your Supervisors to maintain full retirement compensation for new hires.

Retirees Meet Governor Northam

Last fall, I thought it would be a terrific idea to meet with the newly-elected Governor when we went to Richmond for Retiree Lobby Day on January 25. But, how on earth does that happen!! I have been escorting groups of retirees to lobby our issues in Richmond for more than ten years and always figured that the Governor was way too busy for us to take up his time. WRONG!! We are citizens of the Commonwealth who have a right to meet with the Governor just as any other group of citizens.

Luckily, I found that Janet Muldoon, Senator Dick Saslaw's Chief of Staff, was on Governor Northam's transition team. If anybody had access to the Governor, it would be the Transition Team members. When I shared my idea with her, she said, "I certainly don't see why not." But, I had no idea if it would actually happen. To my astonishment, Janet soon emailed and said that Governor Northam would meet with us at 2:30 the afternoon of our Lobby Day!!

Prior to the meeting, we visited all our Fairfax legislators or their legislative staff and took "Welcome Bags" to newly elected members of the House of Delegates, so many of whom were elected with the help of educators. After our busy morning of visiting and lobbying, I instructed our group to, "Meet me at the flagpole after lunch at 2:00!" Little did our seasoned lobbyists know why.

At the appointed time, we met Janet Muldoon at the flagpole who led us up the hill to the Patrick Henry Building, through security, to the Library Reading Room. By this time everyone had pretty much figured that somebody important would be arriving!! Janet gave an eloquent introduction of the Governor's background and told us to stand when he entered the room. And then, there he was! What a kind and gentle soul he seems to be. He is a pediatric neurologist who treats terminally ill children when he is not serving the Commonwealth as Lt. Governor or Governor.

Clearly, our meeting affirmed that education at ALL levels is a high priority for Governor Northam. He talked of filling the vacancies in our classrooms, the necessity of retaining quality teaching staffs, and of course being able to provide adequate salaries. IRS Form 1095

FCPS retirees who were enrolled in FCPS health plan coverage (or who were eligible for coverage but did not enroll) should have received IRS-Form 1095 -C in late February. Much like Form W-2 and Form 1099, which include information about the income you received, Form 1095 provides information regarding your health insurance eligibility and enrollment.

While the information on this form may assist with preparing your tax return, the Internal Revenue Service has stated **you will not need to submit these forms with your tax return**. You should keep the forms for your records with your other important tax documents.

If you have questions regarding how these forms impact your tax return preparation, please check with your tax professional. For questions, please contact the Office of Benefit Services at 571-423, 3200, option 3, to speak with a representative.

New ID Cards for Retirees

Retirees who made changes to their health or dental coverage during Open Enrollment and/or those who transitioned to Aetna Medicare Advantage received new ID cards in December. Show ONLY your new card to your medical providers and secure your original Medicare card in a safe place at home. Cards were not reissued to retirees continuing with the same plan.

FEA-R Council Election Petitions due by April 27

Five FEA-R sets will be up for election in 2018. These two-year seats are held by Larry Armentrout, Mimi Dash, Kathy Davis, Cheryl Perry, and Walt Mika, who are eligible for re-election should they choose to run.

Open Enrollment Ends November 9

Each year, FCPS provides a window of opportunity to review your benefit elections and make decisions about what might be the best option for your unique situation. Open Enrollment opened on October 15 and ends, November 9. Elections made during Open Enrollment become effective January 1, 2019.

Here's how to ensure you are prepared for this year's Open Enrollment:

- 1. By now, you will have received two mailings from FCPS. The first will contain a statement of your proposed plan enrollment for 2019, and the second will be the annual Retiree Benefits Briefing. Your Briefing will contain important information about plan updates and/or changes as well as a schedule of Benefits Open Houses with flu shot clinics.
- 2. Utilize the web. Access the Fairfax County Public Schools Retiree Open Enrollment website (www.fcps.edu and search "retiree open enrollment"). Benefit vendor sites are the quickest to access benefit-related information.
- 3. Keep up with Open Enrollment publications! Be sure you check your email for important announcements through News You Choose and review the materials mailed to your home address. Questions? Call your benefits plan provider (Aetna, Kaiser, CareFirst, etc. Use the Customer Service number on the back of your insurance card or contact Human Resources at 571-423-3000 or via HRConnection@fcps.edu.

AETNA Medicare Advantage Health Assessments

The Aetna Medicare Advantage plan provides two important annual health assessments for members. These assessments help ensure Aetna has information about the status of a member's health and health history in order to determine if additional resources and support may be needed. Aetna is required by the Centers for Medicare and Medicaid Services to conduct these assessments for their members.

Recently, Aetna Medicare Advantage members received a letter inviting them to participate in a Healthy Home Visit, also referred to as an in-home assessment. Members may have also received a call from Advance Health - Aetna's partner vendor for this program. If a member agrees to participate in the Healthy Home Visit, a licensed practitioner (typically a nurse practitioner) will visit the member's home. The practitioner will review the member's health history, check vitals, complete a medication review/ reconciliation, and perform a safety check of the member's home. This visit is intended to supplement — but not replace - a member's relationship with their primary care provider (PCP). If the member has told Aetna who their PCP is, the PCP will receive a summary of the visit.

The Healthy Home Visit is in addition to the Health Risk Assessment conducted earlier this year. Both assessments are conducted annually, and members will be contacted again in early 2019 to participate in the Health Risk Assessment.

New ID Cards for Retirees

After Open Enrollment closes, keep an eye on your mailbox. Retirees who made changes to their health and/or dental coverage during OE will be receiving new ID cards in late December. Please be sure to provide copies of your new card to your medical providers. Cards were not reissued to retirees continuing with the same plan.

FEA-R/FCRE Meeting with HR Sept 19, 2018

The two retiree organizations continue to meet quarterly with representatives from Human Resources to discuss topics of importance to retirees and current employees. Highlights of retiree discussion follow:

Open Enrollment ((Oct 15-Nov 9) – There will be no increase for Medicare Advantage or for non-Medicare Carefirst retirees but a 16.7% increase in the dental plan for retirees. Any new elections will take place on January 1, 2019.

Plan Changes – Complex radiology precertification will be waived for non-Medicare retirees, but they will incur a \$75 co-pay for the procedure. There will be a Kaiser pilot for a Silver and Fit program in 2019 only. Kaiser's physical therapy benefit will now have a 60-day limit. There will also be enhanced payment options for direct bill retirees.

Medicare Advantage – All agreed it was running smoothly and that no changes were forthcoming.

Silver Sneakers – HR will follow up on recreation centers' participation in the program.

Meeting with HR from p. 1

Shingles Shot – Retirees must get the shot using their Silver Scripts card, not their Medicare Advantage Card. The co-pay will be no more than \$28.03, which is a 20% co-pay. As the serum is in short supply, it is best to get on a waiting list at CVS, for example. As a second shot is required in 2-6 months for optimal immunity, one should get on a waiting list again in an agreed upon time with the provider. FCPS will ask vendors for information on this issue.

New HR head – Chief Operating Officer Marty Smith reported that Helen Nixon would attend our next meeting and that she had worked with Benefits Advisory Committees in the past. He added that HR was "already talking about getting input from all our stakeholders...We will see some form of an Advisory Committee coming forward."

Substitute Pay - Marty Smith reported that the system is coming close to a workable solution to address the issue of sub pay and inadequate fill rates. He stated that if the past rate of retiree subs had continued, the fill rate would have been reduced by 2%. He believes that retirees will be "happy" with the outcome. Also, the system will work on incentivizing employees to use less leave. The goal, he states is "to pay subs at a rate that will keep them coming back to the schools." Mimi Dash reminded the group that there used to be a payout for unused sub leave when a person retired. Lee Burton is the contact person for suggestions or concerns. We are urged to attend the October work session when this issue will be discussed.
