Elections November 5 Be an Education Voter

2019 is a particularly important year to vote! All local offices and all General Assembly state offices are up for election. That includes 12 School Board members, 10 Board of Supervisors, 9 Senators, and 18 House seats—all of whom serve districts with constituents in Fairfax County.

If you are going to be out of town, please vote early, and don't forget to make sure friends and family get to the polls which open at 6:00 a.m. and close at 7:00 p.m.

Be sure to turn over your ballot– They are two sided this year and some School Board candidates are on the back. Here is the link to confirm your polling place and get a sample ballot. https://www.vote411.org/

Open Enrollment Ends November 8

Each year, FCPS provides a window of opportunity to review your benefit elections and make decisions about what might be the best option for your unique situation. Open Enrollment opened on October 14 and ends, November 8. Elections for changes to your plan must be made during Open Enrollment and become effective January 1, 2020.

Here's how to ensure you are prepared for this year's Open Enrollment:

1. By now, you will have received two mailings from FCPS. The first will contain a statement of your proposed plan enrollment for 2019, and the second will be the annual Retiree Benefits Briefing. Your Briefing will contain important information about plan updates and/or changes as well as a schedule of Benefits Open Houses with flu shot clinics.

2. Utilize the web. Access the Fairfax County Public Schools Retiree Open Enrollment website <u>https://www.fcps.edu/</u> <u>index.php/benefits-open-enrollment-for-</u> <u>retirees</u> From that site you can see dates and locations for Open Houses, 2020 rates for the three Vendors, and Dental plans, and links for paperwork needed should you choose to change policies or plans. Links to benefit vendor sites are also available from that page and are the quickest way to access benefit-related information.

3. Keep up with Open Enrollment publications! Be sure you check your email for important announcements through *News You Choose* and review the materials mailed to your home address. Questions? Call your benefits plan provider (Aetna, Kaiser, Care-First, etc.) Use the Customer Service number on the back of your insurance card or contact Human Resources at 571-423-3000 or via HRConnection@fcps.edu.

FEA-R/FCRE Meeting with HR October 3, 2019

The two retiree organizations continue to meet quarterly with representatives from Human Resources to discuss topics of importance to retirees and current employees. Highlights of retiree discussion follow:

Open Enrollment (Oct 14-Nov 8) – See Open Enrollment article.

Plan Changes – Medicare Advantage – For both Aetna and Kaiser will continue. Large increases in cost are not expected this year.

Silver Sneakers (Aetna) and Silver Fit (Kaiser)– Will also remain benefits. The county will not be extending benefits through county rec centers due to cost to the county.

Shingles Shots and Pneumonia Immunizations – Retirees may need to get the shingles shot using their Silver Scripts card, not their Medicare Advantage Card. The copay will be no more than \$28.03, which is a 20% co-pay. Don't forget a second shot is required on the Shingles vaccine in 2-6 months for optimal immunity, one should get on a waiting list again in an agreed upon time with the provider. The single Pneumonia vaccination is also highly recommended.

Substitute Pay – Changes have been made to the application process for FCPS retirees which somewhat simplifies applying. Also, the rate for FCPS retirees who work as subs has been increased to \$20.50 per hour for a short term assignment and \$26 for an assignment of 11 or more days.


