Nov 5, 2019 Elections

The elections of November 5, 2019, were historic here in Virginia. Not only did the General Assembly switch to a Democratic majority for the first time since 1996, but Fairfax County's two governing bodies were substantially reconstituted. The Fairfax County Board of Supervisors has four new members, with Jeff McKay moving from Lee district to Chair, and four returning school board members are welcoming eight new members.

Government Relations Team Review Winter Edition

Northern Virginia and Fairfax County, in particular, have continued to ride the BIG BLUE WAVE since our successful elections two years ago. And, on Election Day, November 5 of this year we were able to elect more candidates than was actually necessary to "flip" the majority in the State Senate and the House of Delegates from Republican to Democrat. It has been more than twenty years since the Democrats have had a majority in both Houses of the Virginia Commonwealth's Legislature.

Why is this important?

As educators, the reason that this is important is the fact that Democrats generally have been (and can be expected to continue to be) much more supportive of increasing benefits for school employees, increasing teacher salaries, maintaining the Virginia Retirement System, providing health benefits, and providing a high quality environment in our schools for teaching and learning. SO, as our legislators are creating the language to support the bills that will be introduced during the 2020 General Assembly Session, they are looking at the long term outcome of what their legislation can provide, and how it will shape the future development of programs that will provide new technology, social services to communities in need, and more equitable learning opportunities for all of our students.

On, December 12 and 13, the GRT was host to 15 of our Senators and Delegates (or their Legislative Aides) from Fairfax County at our annual lunch and breakfast to discuss the issues that we feel are important to all educational retirees and to share those with our legislators. We have found that in the last several years as we have transitioned from visits with individual legislators to meeting in larger group situations, we are learning what is important to their constituents and how those needs and issues relate to us as educators. It is a large community and the needs are many!

Bus Stop #2 is the parking lot of the Little River United Church of Christ (UCC) at 8410 Little River Turnpike. It is across from NOVA Community College in Annandale. To access the parking lot of the church, turn left on Lake and follow the long driveway to the parking lot. The bus will leave Little River UCC at 6:30 a.m.

Bus Stop #3 is the parking area around the Cracker Barrel just off Rt. 95 at 17115 Dumfries Rd., Dumfries. The bus will leave that area between 6:50 and 7a.m.

We will be dropped off at the Pocahontas Building in Richmond at 8:30 and will visit with our Legislators through the morning. Lunch is available across the street at the Sun Trust Bank Building. The bus will be picking up our members around 2 p.m. and will return to all stops made in the morning.

2020 VEA-Retired Elections

Government Relations Team Position Statement for the 2020 General Assembly Session

ON BEHALF OF ALL NORTHERN VIRGINIA'S RETIRED EDUCATION EMPLOYEES. WE SUPPORT THE FOLLOWING:

- 1. Fully fund the Virginia Retirement System (VRS) and maintain it as a defined benefit plan without any other option.
 - a. **IMPLEMENT** VRS actuarial recommendations, including continuing to fully fund the Board Certified Contribution Rate to VRS.
 - b. OPPOSE all efforts to erode the VRS retirement plan, and move to reverse action taken that created the hybrid plan.
- 2. Provide equity for ALL education employees, bringing them to the level of benefits provided to state employees in comparable positions.
 - a. Appropriate increases from state funds, NOT from local revenues.
 - b. Provide health insurance credit to all educational support professionals (ESP).
- 3. Passage of the Equal Rights Amendment.
- 4. Legislation to promote gun violence prevention.
- 5. The constitutional amendment to support non-partisan redistricting.

IN SOLIDARITY WITH OUR ACTIVELY EMPLOYED COLLEAGUES, RETIRED EDUCATORS ALSO CALL ON LAWMAKERS TO:

- 6. Commit to providing a high quality environment for teaching and learning.
 - a. Attract and retain highly qualified educators.
 - Recognize the importance of professional autonomy for practitioners and provide avenues for their input.
 - Maintain the current continuing contract.
 - Reinstate the three person fact-finding panel.
 - Restore a three year probationary period for new teachers with access to due process after the first year.
 - Significantly improve educator salaries.
 - b. Continue to examine and evaluate the frequency of and dependency on high stakes testing.
 - c. Promote a teacher evaluation system that uses multiple measures, reduces reliance on standardized test scores, and reflects a teacher's effectiveness and growth.
 - d. Oppose voucher and tax credit plans for private and home K-12 Education.
- 7. Commit to rights of educators to negotiate their salaries and working conditions through an official process jointly developed by the localities.
- 8. Fully fund Department of Education recommended SOQ mandates, including significant reductions in class size, attention to providing a safe learning environment, and revision of the funding formula to more accurately reflect the needs of all localities.
- 9. Oppose charter school amendments and private efforts to impact curriculum and/or any attempts to divert public dollars to non-public schools.
- 10. Support equitable learning opportunities for all students, including improving infrastructure, providing technology, and supporting wrap-around community services.

Virginia has elections every year. This year is mostly focused on the Presidential and Congressional elections.

Next year we will elect the top three Virginia offices and the House of Delegates.

In spite of pandemic restraints, it is critical that everyone vote this year in our Presidential and Congressional elections.

FCPS Benefit Open Enrollment October 15-Dececember 7

Each year, FCPS provides a window of opportunity to review your benefit elections and make decisions about what might be the best option for your unique situation.

Open Enrollment opened on October 15 and ends, December 7. Elections for changes to your plan must be made during Open Enrollment and become effective January 1, 2021.

By now, you should have received a mailing from FCPS containing a statement of your proposed plan enrollment for 2021. Review your selections. If you have no changes, you don't have to do anything else.

However, you may want to go to the FCPS Retiree Benefits website and review details of this year's plan. Though there are not substantial changes to this year's coverages, every year the providers have what they consider minor changes but ones that may affect your particular health needs. Such as a \$50 cap on insulin co-charges, and approval of acupuncture for back pain. (see the individual plans for details)

You will definitely want to access the Fairfax County Public Schools Retiree Open Enrollment website. That is where you will find 2021 premium rates, changes to plans like copays and new benefits details, and paperwork for any plan changes you would like to make.
