Betsy DeVos resigned as Secretary of Education this week, and we have been witnessing unprecedented tragic history in the capital.

With hope and solidarity for a caring common humanity, and the chance to more safely venture out soon.

# Government Relations Team (GRT) Position Statement

# for the 2021 General Assembly Session

# ON BEHALF OF ALL NORTHERN VIRGINIA'S RETIRED EDUCATION EMPLOYEES, WE SUPPORT THE FOLLOWING:

1. Fully fund the Virginia Retirement System (VRS) and maintain it as a defined benefit plan and as the sole option.

**IMPLEMENT** VRS actuarial recommendations, including continuing to fully fund the Board-Certified Contribution Rate to VRS.

**Move** to reverse action taken that created the hybrid plan. **OPPOSE** all efforts to erode the VRS retirement plan.

 Provide equity for ALL education employees, bringing them to the level of benefits provided to state employees in comparable positions. Appropriate increases from state funds, NOT from local revenues.

Provide additional health insurance credit to all educational support professionals (ESP).

3. Support legislation to promote criminal justice reform.

# IN SOLIDARITY WITH OUR ACTIVELY EMPLOYED COLLEAGUES, RETIRED EDUCATORS ALSO CALL ON LAWMAKERS TO:

- 4. Commit to providing a high-quality environment for teaching and learning.
  - a. Attract and retain highly qualified educators.
    - Support legislation which promotes professional autonomy for educators and staff, and provide avenues for their input.
    - Maintain the current continuing contract.
    - Provide access to due process after the first year of the probationary period.
    - Significantly improve educator salaries by providing a 5% increase each year of the biennium.
    - Restore education funding approved in the 2020 budget.
  - b. Respond to the pandemic by properly equipping schools with appropriate and necessary safety materials and equipment with attention to healthy air quality.
  - c. Continue to reduce the frequency of and dependency on high stakes testing.
  - d. Establish evaluation systems that use multiple measures, reduce reliance on standardized test scores, and reflect effectiveness and growth.
- 5. Strengthen rights of educators to negotiate their salaries and working conditions through an official process jointly developed by the localities.

#### 6. Fully fund Department of Education recommended SOQ mandates, including:

- restoring counselors and psychologists as recommended in the 2020 SOQs,
- significant reductions in class size,
- providing a safe learning environment,
- lifting the support staff cap, and
- revising the funding formula to more accurately reflect the needs of all localities.
- 7. Support the recruitment and retention of a diverse and qualified staff.
- 8. Oppose independent charter schools and oppose and eliminate private efforts to impact curriculum and/or any attempts to divert public dollars to non-public schools.
- 9. Support legislation that improves infrastructure, provides technology, and supports wrap-around community services.

# FCPS Benefit Open Enrollment October 11– November 5

Fall 2021

Open Enrollment began on October 11 and ends November 5, which is considerably shorter than recent years.

Elections for changes to your health plan must be made during Open Enrollment and become effective January 1, 2022.

You will find 2022 information sessions, premium rates, changes to plans like copays, new benefits details, and paperwork for any plan changes you would like to make there. Links to benefit vendor sites are also available from that page and are the quickest way to access benefit-related information.

The only changes of major significance for retirees in 2022 are an increase in available dental coverage to \$2,000 per year and a premium increase of 5.2% for Aetna Medicare Advantage enrollees. A handful of generic pharmaceutical choices has been changed.
